#### **Strong projects and the diversity of dance**

The first round of the match-funding programme *TANZPAKT Stadt-Land-Bund* (Dance Pact Local-Regional-National) supported eight substantial projects aimed at supporting the further development, strengthening and profiling of dance in Germany, both artistically and structurally.

The projects cover a wide-ranging remit from the national development of dance for young audiences via new dance locations and structures up to co-operations between major institutions and independent dance ensembles, and the further development of artistic practice.

#### **The countdown has begun – the application deadline is 14.12.2018 – consultations are still possible**

Consultation appointments can still be made with the non-profit agency DIEHL+RITTER and/or the *Dachverband Tanz Deutschland* (The Association for Dance in Germany) until the close of applications on 14<sup>th</sup> of December 2018. It is recommended that all potential applicants seek advice from the agencies operating the funding programme before submitting their applications.

DIEHL+RITTER offers advice on all questions relating to the specific application procedure for the promotional fund.

The *Dachverband Tanz Deutschland* is active in the cultural-political dialogue and supports the interaction between dance professionals, administrations, and city and federal-state policy.

Approx. EUR 2.2 million will be awarded in the second round of applications, a sum that must be match-funded to at least the same level by federal state and/or local government funding as well as funds from other sponsors. The minimum duration of the projects is 30 months. The independent jury of experts is expected to sit in March 2019.
